

## **Award Category for Nomination – Criteria**

### **Outstanding Civil Engineer in Private Sector**

1. This award is given on the basis of outstanding engineering achievement. Consideration shall be given to the Engineer that has exhibited professional achievement, leadership, and exceptional dedication in the Private Sector and who has made significant impact to the field of civil engineering. This impact may be through professional activities, ASCE involvement, research and innovative engineering solutions.
2. This award is intended to be awarded to individuals in the Private Sector (i.e. not a public agency or public organization employee)
3. The nominee for this award shall be a Registered Professional Engineer and be a member of Sacramento Section of ASCE.

### **Outstanding Civil Engineer in Public Sector**

1. This award is given on the basis of outstanding engineering achievement. Consideration shall be given to the Engineer that has exhibited professional achievement, leadership, and exceptional dedication in the Public Sector and who has made significant impact to the field of civil engineering. This impact may be through professional activities, ASCE involvement, research and innovative engineering solutions.
2. This award is intended to be awarded to individuals employed by a public organization.
3. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

### **Outstanding Younger Civil Engineer**

1. This award recognizes the professional achievements, leadership, and exceptional dedication and service of younger civil engineers within the Sacramento Section. The award recipient shall be the person, in the judgment of the Awards Committee, who has best demonstrated these traits and has brought distinction upon himself/herself, our Society and the field of civil engineering. Distinction and impact in the field of Civil Engineering may be through professional performance, ASCE involvement, community service, research and innovative engineering solutions.
2. This award is intended to be given to an individual aged 35 years or less as of October 1 of the year of the award.
3. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

### **Outstanding ASCE Section Officer**

1. The award is given annually to an outstanding ASCE Officer within the Sacramento Section. This award is intended to recognize dedication, hard work and ingenuity that Section officers provide to ASCE. Consideration shall be given to the Section Officer who has exhibited exceptional leadership, management, service, or innovative ideas to the Section.
2. The nominee for this award shall be a member of the Sacramento Section of ASCE.
3. The nominee must be an Officer for the Sacramento Section of ASCE for the year the award is given.

### **Outstanding Branch Officer**

1. The award is given annually to an outstanding ASCE Officer at the Branch level within the Sacramento Section. This award is intended to recognize dedication, hard work and ingenuity that Branch officers provide to ASCE. Consideration shall be given to the Branch Officer who has exhibited exceptional leadership, management, service, or innovative ideas to the Section.
2. The nominee for this award shall be a member of the Sacramento Section of ASCE.
3. The nominee must be an Officer for a Branch in the Sacramento Section of ASCE for the year the award is given.

### **Outstanding YMF Officer**

1. The award is given annually to an outstanding ASCE Younger Member Forum Officer within the Sacramento Section. This award is intended to recognize dedication, hard work and ingenuity that YMF officers provide to ASCE. Consideration shall be given to the YMF Officer who has exhibited exceptional leadership, management, service, or innovative ideas to their YMF.
2. This award is intended to be given to an individual aged 35 years or less as of October 1 of the year of the award.
3. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.
4. The nominee must be a YMF Officer in the Sacramento Section of ASCE for the year the award is given.

### **Best Civil Engineering Event**

1. This award recognizes an outstanding event focused on enhancing the public understanding of Civil Engineering. This award is intended to recognize dedication, hard work and ingenuity of teams focused on advancing the profession through public events and services.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.
3. The nominee must be for an event hosted or chaired by a member of the Sacramento Section of ASCE for the year the award is given.

### **Outstanding Civil Engineering Faculty Advisor**

1. The award is given annually to an outstanding faculty person who supports ASCE student chapters and civil engineering students within the Sacramento Section. This award is intended to recognize faculty contributions to civil engineering students and their activities.
2. The nominee must be active with ASCE students at an ABET accredited Civil Engineering program at a University located within the area served by the Sacramento Section the spring of the year the award is given or the fall of the previous year. Nominee may be faculty member or a lecturer.
3. Describe the nominee's involvement with the Student Chapter of ASCE and/or civil engineering students.

### **Outstanding ASCE Practitioner Advisor**

1. The award is given annually to an outstanding Practitioner Advisor within the Sacramento Section who supports an ASCE student chapter and/or civil engineering students. This award is intended to recognize Practitioner Advisors' contributions to ASCE Student Chapters and their activities.
2. The nominee must be active with ASCE Students in the Sacramento Section of ASCE the spring of the year the award is given or the fall of the previous year.

### **Outstanding Civil Engineer in Community Service**

1. This award recognizes the efforts of civil engineers in community service within the Sacramento Section. The award recipient shall be the person, in the judgment of the Awards Committee, who has best demonstrated outstanding community service and has brought distinction upon himself/herself, our Society and the field of civil engineering through these efforts. This award is given on the basis of demonstrated community service with an emphasis on a diversity of service.
2. This award is intended to be given to an individual who has been engaged in community service outside of their day-to-day job and exclusive of their service to ASCE. Areas of service include but are not limited to participation in service clubs, community activities, political service, school boards and planning commissions, Engineers Without Borders, religious activities, youth service and coaching, service to the less fortunate, public awareness campaigns, organizing community events, etc.
3. The nominee for this award shall be a Registered Professional Engineer and be a member of the ASCE in the Sacramento Section.

### **Humanitarian**

1. The award is given annually to an outstanding Sacramento Section member who supports ASCE's mission through dedication of time and involvement with humanitarian efforts, local Section affairs, safety, social services, and the like.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the ASCE in the Sacramento Section.

### **Excellence in Journalism**

1. The award is given annually to a reporter(s), writer, or other journalist whose work enhances public understanding of civil engineering and/or the importance of infrastructure to society within the Sacramento Section.
2. The award is given on the basis of how well the nominee a) fairly covers all sides of the civil engineering project or issue; b) accurately describes the civil engineering project or issue; c) effectively explains how the project or outcome of the issue benefits the company or region; d) clearly shows the civil engineer's role; e) includes the most knowledgeable civil engineering experts; and f) advances public knowledge and understanding of civil engineers, our issues and profession.
3. Only journalists from general (nontrade) publications are eligible. The publication(s) must be regional or local.
4. Please include article(s) and/or publication(s).

### **Outstanding ASCE Life Member**

1. The award is given annually to an outstanding ASCE Life Member. This award is intended to recognize the current efforts of active Life Members who have contributed to the advancement of our Society and its members by devoted service to the Region, Section, Branch, Life Member Forum, Younger Member Forum and/or Student Chapter.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of ASCE Sacramento Section. This award is intended to recognize the current efforts of active Life Members who have contributed to the advancement of our Society and its members by devoted service to the Region, Section, Branch or Life Member Forum.
3. Include nominee's ASCE involvement over time and nominee's other professional activities.

### **Lifetime Achievement Award**

1. This award recognizes the lifetime achievements of civil engineers within the Sacramento Section. This award is intended to recognize the lifetime efforts of civil engineers who distinguish themselves and ASCE through their contributions, innovative concepts, research, and publications.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.
3. Describe any notoriety the nominee has achieved in the field of civil engineering. This should include the nominee's ASCE involvement.

**Arthur Elliot Bridge**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques in bridge-building, researched bridge design, and provided outstanding service to the profession of bridge engineering.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**Charles Pope Construction**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques in construction, engaged in materials research, and provided outstanding service to construction and engineering.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**Francis Hveem Geotechnical**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques in geotechnical methods, engaged in materials research, and provided outstanding service to geotechnical engineering.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**Fredrick Panhosr Structural**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques and provided outstanding service to structural engineering.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**William Hall Flood Control**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques and study in flood control systems, and provided outstanding service to engineering in the field of flood control.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**David Kennedy Water Resources**

1. This award recognizes engineers in the Sacramento Section which have furthered techniques in flood control and water supply, and provided outstanding service to engineering in water resources.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

**Jonathon Burdette Brown Education**

1. The award is given annually to an outstanding engineer who supports ASCE and civil engineering students and furthers the education of engineering through written and oral presentations and mentorship.
2. The nominee for this award shall be a Registered Professional Engineer and active with ASCE within the Sacramento Section. Nominee may be not be a college / university faculty member.
3. Describe the nominee's involvement with the Student Chapter of ASCE and/or civil engineering students.

**Steward Mitchell History & Heritage**

1. This award recognizes engineers which have furthered the education of engineering history in the Sacramento Section.
2. The nominee for this award shall be a Registered Professional Engineer and be a member of the Sacramento Section of ASCE.

### **Transportation Engineer**

1. This award is given on the basis of outstanding engineering achievement specifically related to Transportation Engineering. Consideration shall be given to the Engineer that has exhibited professional achievement, leadership, and exceptional dedication in either the Private or Public Sector and who has made significant impact to the field of transportation. This impact may be through professional activities, ASCE involvement, research and innovative engineering solutions.
2. This award is intended to be awarded to individuals in the Private or Public Sectors.
3. The nominee for this award shall be a Registered Professional Engineer and be a member of Sacramento Section of ASCE.

### **Legislative Activities**

1. This award is intended to recognize the efforts of the Civil Engineers to further advance the interests of the Society and Profession in legislative activities through involvement and outreach.
2. This award is given on the basis of an outstanding engineering achievement accomplished within the most recent award period established by the Sacramento Section. Consideration shall be given to the Engineer that has exhibited professional achievement and has made significant impact in legislative activities. This impact may be through professional activities, legislative outreach, coordination, and other activities that address the Society's goal of involvement in local and regional legislative activities.
3. The nominee for this award shall be a Registered Professional Engineer and be an active member of the Sacramento Section of ASCE.

### **State Legislator of the Year**

1. This award is given on the basis of contributions made by State Government by authoring and/or supporting initiatives in favor of engineering progress and the welfare of the public.
2. The nominee for this award shall be a State legislator, congressperson, etc.
